In 1977, he founded Hoffmann Architects + Engineers, and he was elevated to fellowship in the American Institute of Architects in 1992 for significant contributions to the field of architecture. In 2006, he was named a Richard Upjohn Fellow of the AIA for service to the profession. An alumnus of the City College of New York, he serves on Hoffmann's Executive Committee and Board of Directors.



Russell M. Sanders, AIA is President of Hoffmann Architects + Engineers. He joined the firm in 1978 after earning a B.S. in architecture from Ohio State University. For decades, he has led the architecture and engineering staff across all three offices, overseeing the quality and accuracy of all technical documents produced by the firm.
